Creating Friendships for Peace (CFP) promotes peace and understanding in divided communities by bringing together teenagers with future leadership potential from both sides of a conflict, encouraging lifelong friendships among them, and extending these friendships to their families and friends.

Creating Friendships for Peace (CFP) provides Cypriot teens, paired bi-communally, with a month-long living experience with U.S. host families in the United States. In 2019, CFP funded 20 Cypriot teen pairs, i.e. 40 students, in four areas (MD, NH, SF, and Portland, OR/ Southwest WA). While in the U.S., the teen pairs experience group workshops within their areas on team building, conflict resolution, community service and environmental issues. These activities focus the students on issues they share in common rather than on issues that divide. Each area of the country uses its uniqueness to teach the lesson of reconciliation.

Our program in Cyprus is referred to as the Cyprus Friendship Program and includes our independent volunteer Cypriot Coordinators who manage our program on the island. The program includes workshops, projects and a week long summer peace camp, which are all funded with Cypriot resources and do not rely on the U.S. organization.

Almost all of CFP's expenses for the Cyprus Friendship Program are related to the travel and insurance costs for the teen pairs who come to the U.S. As of the end of 2019, CFP has paired and trained 524 Cypriot teens in the United States and 386 in Cyprus.

Creating Friendships for Peace continued a partnership with another peacebuilding organization, Jerusalem Peacebuilders. CFP provided 20 Israeli and Palestinian teens, paired across a conflict, with a two week living experience with US host families in the United States, before their two week camp experience with Jerusalem Peacebuilders. This class of 20 teens lived in NH, MD, SF and OR/WA and experienced group workshops within their areas on team building, community service and environmental issues in combination with teen pairs from Cyprus.
